## What to expect...

### Clothing recommendations:

As seen above, there are a couple of level clothing: casual and advanced. Don't worry about wearing anything special, but make sure it's ok to get dirty. Most paintball paint will completely wash out of clothes, but it's a little more difficult to get out of whites.

### Does paintball hurt?

Paintballs can hurt a little bit when they break, but if you wear the right clothes, you may not even feel them. Loose fitting clothes can catch the paintballs and slow them down before they break. Gloves can help pad the hands and padded vests are available for rent. The face is very well protected by the player's mask, but typically masks do not cover the top of the player's head. A hat or beanie is recommended for padding, plus it also helps to keep paint out of the hair. Occasionally bruising can occur, so for your best protection, don't stand in the open.
